What are the requirements for operating equipment under subpart cc?

Operator training, certification, and evaluation. General requirements for operators. The employer must ensure that each operator is trained, certified/licensed, and evaluated in accordance with this section before operating any equipment covered under subpart CC, except for the equipment listed in paragraph (a) (2) of this section.

Do equipment operators have to be licensed under subpart cc?

Licensing. When a state or local government issues operator licenses for equipment covered under subpart CC, the equipment operator must be licensed by that government entity for operation of equipment within that entity's jurisdiction if that government licensing program meets the following requirements:

When is an operator-in-training monitored in multiple-lift rigging operations?

In multiple-lift rigging operations, except where the operator's trainer determines that the operator-in-training's skills are sufficient for this high-skill work. The employer must ensure that an operator-in-training is monitored as follows when operating equipment covered by this subpart:
